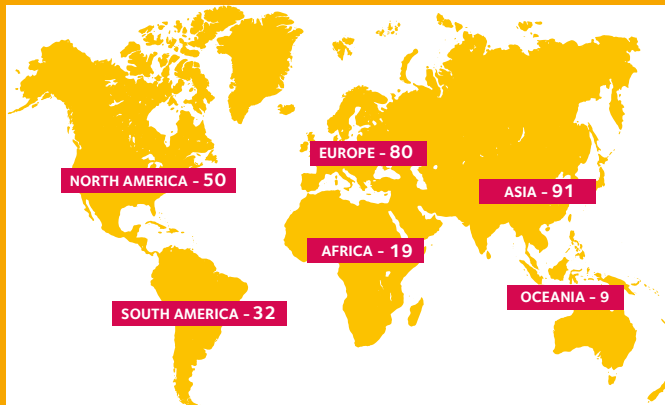

General Admission Process

Admission is based on each student's online application available at <https://application.ieseg.fr/> and the review of the required documents by an Admission Committee.

APPLICATION CHECKLIST

- Online application form
- Undergraduate degree in business management or related field (transcript and diploma)
- Unless otherwise waived, an English proficiency test is required (IELTS 6.5, TOEFL iBT 85, TOEIC 800)
- CV/Resume + Motivation letter in English
- Copy of passport

TUITION FEES & SCHOLARSHIPS

- Master in Management - Grande École Program : €10,274 per year
- Msc in International Business Negotiation: €14,000
- MSc in International Business, Business Analytics & Consulting, Accounting, Audit & Control, Investment Banking & Capital Markets, Digital Marketing & CRM and Big Data Analytics for Business : €15,000
- MSc in Fashion Management and Finance: €16,000
- International MBA: €24,000

10% reduction on the fees for students coming for a double-degree or a joint program.

Other mandatory fees may include social security and Alumni Association fee, up to €750



IÉSEG APPLICATION PROCESS – DOUBLE DEGREE AND JOINT PROGRAMS



1. Contact your home university international relations team in order to apply for the program.



2. After being preselected by your school, you are ready to be interviewed by an IÉSEG representative.



3. Connect to the application platform. Make sure you select the right program (do not create two applications) – <https://application.ieseg.fr>



6. Your application will be reviewed by the Admission committee within 15 days.



5. During the interview, please give ALL the required documents to the IÉSEG representative.



4. Complete the application form and print it.



7. You will receive the admission result by e-mail. Admitted ? Congratulations!



8. Secure your place with a deposit of €1,600 before the deadline.



9. You will then receive your official letter of acceptance: start your Visa procedures as soon as you can and fill in your official registration file.
